



- Cargo: crawler crane
 - Value: 25.000.000 Euro
 - Lease: 250.000 Euro p/m
- Vessel: general cargo
 - 20.000 usd p/d






Case Study 1: wetting

Lessons learned:

- Time pressure
- Weathertightness
- Pre loading survey





Case Study 2: Containers overboard



- Lack of cargo to survey
- Causes: cargo surveyors are generally not given access to the vessel to inspect the equipment that has failed and to obtain copies of stowage plans, passage plans and log book entries...
 - Stowage errors by the carrier;
 - Stowage errors by the shipper;
 - Defective equipment i.e. an unseaworthy vessel;
 - Interaction between the ship and sea conditions; and
 - Extreme weather


